### 1. Comparative Analysis: themes & initiatives

During a meeting held in Wageningen in June, a number of PhD students and staff reviewed the status of the programme's comparative themes, to see what initiatives have been developed and who is involved (minutes were circulated and will be available on the ftp-server (\CCNR meetings). It was decided to integrate a number of themes, which has resulted in the following 7 themes:

**1. Boundaries; 2. Land and Water (including access and rights); 3. (re-) Settlement; 4. Policy and Practice; 5. Cross-border dynamics; 6. Natural resources and Livelihoods: Use, benefits and resource dependency; 7. Issues of Methodology.**

### 2. Annual workshop 2008: Massingir, Mozambique (8-12 december)

As most of you will already know, the Competing Claims annual workshop will take place in Massingir, Mozambique, from 6-12 December. Nearly 35 students, staff and representatives of partner organisations will participate in this workshop, which will focus on achievements, progress and look forward at the explore phase of the programme's NE-DEED research cycle. All PhD students will present and reflect upon how they are tackling (or going to tackle) the explore phase and, particularly, involve stakeholders in this process. The workshop's prime aim is to provide a forum in which PhD students can present new ideas, problems of analysis, etc.

### 3. PhD projects

*Chaka Chirozva*, PhD student with the Communication & Innovation Sciences (CIS) group, has returned to Zimbabwe after completion of his course work and PhD research proposal. He will start fieldwork in the Southeastern lowveld of Zimbabwe.

*Edson Gandiwa*, PhD student with the same group and the Resource Ecology group is rounding-off his research proposal in Wageningen, before returning to Zimbabwe early december.

*Steven Matema* has completed a scoping study on livestock-related competition for resources in the Mid-Zambezi Valley, Zimbabwe. He has joined the Animal Production Systems group of Wageningen University to develop his PhD proposal. His fieldworks is expected to start in 2009.

PhD students *Yves van Leynseele* and *Jessica Milgroom* are currently in the writing phase, while all other PhD students are currently in the fieldwork phase of their respective projects.

### 4. WCS-AHEAD seed grants for Competing Claims PhD-researchers

In an open competition funded by a number of international donors, the Wildlife Conservation Society (WCS) undertook a Seed Grant initiative within the framework of the AHEAD-GLTFCA programme (Animal Health for the Environment And Development-Great Limpopo Transfrontier Conservation Area). Ten conservation and development proposals focusing on the wildlife-livestock-human interface have been funded, including three to *Competing Claims* researchers:

- *Balancing ecotourism & livestock production: Implications for livelihoods & the environment.* Cheryl McCrindle and Petronella Chaminuka, University of Pretoria and Wageningen University.
- *Alternative sustainable futures for post-Resettlement in Limpopo National Park, Mozambique* Ken Giller and Jessica Milgroom, Wageningen University.
- *Exploring future ecosystem services: A scenario planning approach to uncertainty in the southeastern lowveld of Zimbabwe.* Cees Leeuwis and Chaka Chirozva, Wageningen University

## 6. Competing Claims ftp-server launched: facilitating information exchange

The *Competing Claims* programme introduces a new way for exchanging electronic publications (PDFs), references to relevant literature (Endnote libraries), programme documents, information on past workshops, powerpoint presentations and templates, etc.

*Competing Claims* researchers and staff will obtain access to this restricted access site, as an alternative for the slow and – in southern Africa – often inaccessible *Competing Claims* portal. Participants will receive a manual by e-mail explaining how to connect and use the ftp-server.
